Duchesne County Fair Barrel Race Rules 2014

- <u>; -</u> Open – Anyone, any age can enter and win the saddle. The saddle will be awarded to the contestant that comes closest to their predicted time. Tie will go to the fastest time
- Open 5 D format, ½ second splits. Payout 70%.
- ω go to the fastest time. The winner of the rifle, must pass a firearm background check and be 18 years of age or older. If for any reason the Men's – 18 and up can enter and win the gun. The rifle will be awarded to the contestant that comes closest to their predicted time. Tie will winner can not be legally awarded the rifle it will be awarded to the next closest time.
- Men's 4D format, 1 second splits. Payout 70%.
- 5 A hit barrel, or broken pattern will be considered a NO TIME and not be eligible to win either the saddle or the rifle
- 6 Standard barrel pattern. 90 feet between barrels 1 and 2; 105 feet between barrels 1 and 3 and between barrels 2 and 3; 60 feet from barrels 1 and 2 to the score line
- .7 You must keep continuous motion without use of stopwatch for timing purposes or anything else considered un-sportsmanship like by the event committee
- 00 A contestant can enter as many times as they like as long as it is on different horse that is not entered in that same division. A horse can be entered in both the open and the men's race.
