Each of the undersigned expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Utah and that if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect.

I/we hereby release, waive, discharge, and covenant not to sue County.
